As per the orders of the Honorable Calcutta High Court, dated 13th October, 2020 in the Writ petition WPA 5890 of 2020 regarding the fees to be charged by private unaided schools for the session 2020-2021, We hereby would like to inform you the following: -

1. In compliance with the orders of the Honorable Calcutta High Court, all adjustments as per the revised fee structure (given below) shall be made along with the fees for 4th quarter.
2. The School Managing committee appeals to you to kindly pay up school fees till 3rd quarter on or by 08.12.2020, considering that Abhinav Bharati High School has one of the lowest fees structure amongst the city schools. We are also thankful to all the parents/guardians who have been clearing fees on time which has so far helped us for smooth running of the institution.
3. The “Honorable High Court, Calcutta” in the order dated 13th October, (Paragraph 61, sub clause No. 7, page 50) also stated:

“Parents and guardians of students are requested not to avail of the reduction in schools fees, if their financial situation does not merit the reduction.”

In accordance to the above the School Managing Committee also requests parents/guardians who do not have any financial distress to kindly not avail the reduced fees and pay the fees as per existing fees structure.

4. The Committee also wishes to remind to some of the parents/guardians who have not cleared their dues for the previous session 2019 - 2020 to clear the outstanding fees immediately.


